2. Monthly Updates

2.1 Market Share

2.3 Validation / Derivation

APRA did not change the validation and derivation rules this period. These will **NOT** be updated.



3. Code Updates

3.1 CU68: Workflow errors due to CUBE_Attribute_PET process.

The Workflow update was creating an error when updating caused by the inclusion of the COVID forms in the PET process, these would error if the COVID form was not present in the client's version of CoreBIS. This has been fixed.



4. Enhancements to Existing Features

4.1 EF49: Reconcile feature to have weighting

Raised at CAB: Added a weighting column to the module so that values can be adjusted.

4.2 EF52: Only run Table Mapping for the active form version

The Table mapping process would error when attempting to apply table mapping for versions that were not active. This is common when new form versions come out and the mapping is copied to the new version, both the new and old form version would attempt to run. The process now only runs for the active form version for that period.

4.3 EF53: Additional logging of overnight process

A new folder has been added to the stage folder (temp) called "Execution Status" this folder will have a file written per overnight dimension and cube update, this will allow users/admins to see which dimension/cube update the process is up to. The process log is only updated after an execution, so this method will allow updates to be monitored easily.

The files will be deleted after a period of time using the backup script.



No new features have been released this period.
