# 3. Code Updates

# 3.1 CU26: Manual added Forms not working 100%

If a new form is required to be completed from APRA, and it is a completely new form that has not been completed before then the required taxonomy updates will not be available in the system until the form has been added to D2A. An example of this was the addition of the ARF\_743\_0 for many of our clients, where that form had not been completed previously.

The solution is to create a manual xml file containing this form with its version for the desired period. This manual file will then trigger all of the SBR updates required in the system.

An update has been added to CoreBIS to stop a form from been manually added in the Return Management Screen should it not previously been completed.

# 3.2 CU80: Manually added Forms not integrating in trend reports, etc.

Should a form be manually added to the Return Management Screen it should be included in the trend report and other comparison reports. Currently the APRA only periods are reported in any reports. The update allows these manual periods to show up.

#### 3.3 CU81: Validation rule - 37247286

Check that the validation rule calculates correctly.

The validation rules do not like decimal places. Check that values with decimals calculate correctly.

# 3.4 CU87: 748 - 1.3 Total Outstanding Debt Securities

The Interest Rate derivation values are not calculating correctly on the ARF\_748.

Raised by: Beyond Bank.

# 3.5 CU88: 747 - Derivations not calculating when referencing CBDT\* attributes

The Rules were missing for v8 of the 747, this fix adds the same rules are v7.

Raised by: Beyond Bank.

### 3.6 CU89: Validations appearing as Failed when not calculated

The COND formula has previously been skipped by the validation rules, this additional function has been added to the rules. All rules with the contained will now evaluate.

## 3.7 CU90: EFS Forms - CHECKING

Some users reported missing derivation fields in the forms (grey fields) and some names labels issues were added with a new submission of forms. Current ADI forms were updated from the PET website. The recreation of forms was part also of CU 92, CU 93 and CU 97 fixes. The goal is to display derivations and labels correctly.

# 3.8 CU91: Mapping by Form – Selection

The Mapping by Form screen wasn't looking at the Cube attribute for the Data source but rather the Data Source itself. When a Data Source was a \_1 data source the frontend wouldn't allow the dimensions to be selected.

# 3.9 CU92: Tables do not format correctly when form is exported.

Some forms with dynamic tables (tables that maybe contain variable rows) were incorrectly exported in TM1Web as Slices or Snapshots with numbers spoiled over other tables, e.g., ARF\_747\_0B.

This issue only happened in forms with tables with variable number of rows. The code update is that the users can export the forms without any formatting errors from the TM1Web export functionality.

#### 3.10 CU93: Action buttons shrunk

Some forms were reported with shrunken action buttons. As part of the correction of forms in the CU 90 table all the buttons should show the correct sizing. The reported screens were data quality and movement when applied.

# 3.11 CU94: Regenerate workflow doesn't clear data locking.

When a workflow is regenerated, and that workflow has data tasks that have been submitted on regeneration the data is not unlocked even though the workflow tasks are reset.

Issue was raised with 3 rules on the ARF\_748\_0B where this table has no values and no members had ever been created for it. A work around for this was to create an item in the table using manual adjustment and then remove the value, so in the background a member exists. This has been fixed.

#### 3.17 CU100: CoreBIS SQL Preview

When using the SQL Preview screen, it was reported that if the value in the first column was null no values were displayed in the SQL Preview. This was corrected to allow the display the preview values regardless of the value in the column of the first row.



# 4. Enhancements to Existing Features

### 4.1 EF51: D2A update button, execute and email when complete

Add an additional email to the end of the master d2a process, so that if a user is manually running the process it will send them an email when it finishes.

# 4.2 EF68: Message when data loads fail emailed. Similar to the email you receive when it loads successfully.

Updated the BASE cube load and the TAGGED cube load processes to send error emails should an error occur. This will only occur if a minor issue occurred, any major issues would stop the process and no email will send, however 99% of data load issues are minor.

# 4.3 EF71: Order Deposit balance on Forms

After our last update to table ordering, whereby the order was alphabetical, it was reported that some of the dynamic tables had incorrect ordering, for example in 747\_0B the Deposits outstanding were in a different order causing some confusion for users.

A new process was setup to order the table rows based on a user specified order. By following the steps below, the selection will be ordered correctly.

## 4.4 EF73: Update tagging screen so that it can be sorted numerically

Add a sort field to the tagging screen that allows the screen to sort either by number or text.

This will allow a resubmission that only affects 1 data source (i.e General Ledger updates) to be setup with the other datasources (i.e. Loans Data) referencing the existing submission data.

# 4.6 EF81: Workflow Security

When a new user is added to the system they will not be able to see any prior workflow versions, a new feature has been added to allow an old workflow version to be set to "Read Only for All", which will allow users to see all the tasks in that workflow as read-only.



# 4.7 EF83: Adding Trend to Movement report

Adding the "Trend Analysis" button to the Movement report so that users can go straight to the trend graphing from the movement report.

# 4.8 EF84: Ordering of Returns in Workflow based on due date.

When a workflow is generated the form/return tasks should show in data order.

## 4.9 EF86: Drill datasource screen, show NIL mapping items.

The drill – datasource screen will only show the datasources if there is a value for that data source. This means that to change mapping for a data source that isn't showing a user must first click on the "All Unrounded Sources" then in the mapping screen select the datasource at the top of the page. This enhancement will allow a user to turn off Zero Suppress and see all data sources, there will be a \* next to the data sources with mapping. A user can select the 0 value and click Mapping and it will directly go to the mapping for this data source.

## 4.10 EF87: Workflow submission message

Should a user have many tasks they wish to submit at the same time they can click on the consolidation level task and submit, this will submit all task below. If a user does not have access to all tasks below an error message will appear. This enhancement will remove this error message should this situation occur.

# 4.11 EF89: Sperate Edit Source and Edit Structure on CoreBUILD Dimensions

The Edit Source button was used to go to relevant pages for updating the source of the dimension, this however needed to be split into 2 as some dimension types can allow both functions.

# 4.12 EF91: Changes to dimension alias's where used in mapping cause issues

If a dimension is updated and the description of the element is changed then if this element is used in mapping as an input cell, then this mapping will stop working. This is particularly an issue when a user changes a TAGGED Measure dimension descriptions as these are extensively used in the mapping.


