2. Monthly Updates

2.1 Market Share

This month the following was updated;

- Monthly ADI statistics
- Quarterly Performance Statistics
- Quarterly Property Statistics

2.3 Validation / Derivation

The validation and derivation rules were updated.

3. Code Updates

3.1 CU43: Mapping Version rollover requires security refresh.

Raised by Bank Australia: Added a security refresh to the end of the rollover process.

3.2 CU44: Drilling on submission return version gives error

Raised by Beyond Bank: Fixed the drill process to lookup the correct parameter for mapping version.

3.3 CU45: New SBR dimensions are classified as Daily when using Cube Dimension add

Raised by Beyond Bank. Fixed the Dimension addition process to update the Dimension type.

4. Enhancements to Existing Features

4.1 EF28: Enhancement to mapping on tables

Raised by Teachers Mutual Bank. Table attributes are mapped at the consolidated level using the mapping screen. Only measures could be set at the consolidated level, all others required individual table item attributes to be mapped, thus causing issues with newly created table items. An update was applied so that mappings added to the consolidated attributes will apply to all the table items as well.

4.2 EF29: Expanded the Tagging Levels from 3 to 10

Raised by AMP. The tagging screens have all been updated to allow 10 levels of assumptions, so that even the most complex requirements can be tagged in CoreBIS.
